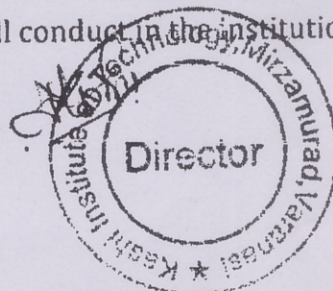

The institution and organization shall not in any way use of party's trade name, trademark, and logo without the use of mutual consent

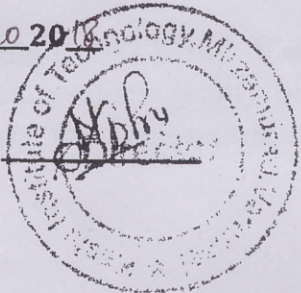
