MEMORANDUM OF UNDERSTANDING

The memorandum of understanding (the MOU) is made and entered on 1st of April 2022.

BY AND BETWEEN

Kashi Institute of Technology, having its campus on MS 23 Varanasi-Allahabad Highway, Mirzamurad, Varanasi, 221307.

Kashi Institute of Technology has agreed to go for alliance with Suryansh Hospital, Birbhanpur, Rajatalab, Varanasi (U.P.), so that Suryansh Hospital can:

- Provide good health, safety and well-being to all their students & employees.
- Access to competent occupational health advice and support.
- Improve access to preventive care and treatment for common health problems.

Now this MOU is witnessed and agreed by and between the parties as follows:

1) Suryansh Hospital will provide an MBBS doctor for medical OPD facility to the students and staff of Kashi group of institution.

Package includes:

- I) Weekly visit of any one doctor.
- II) Pick up and drop of the visiting doctor.
- III) Ambulance facility from the institution to hospital in case of any emergency.

2) For the purpose of identification KASHI Group shall provide each beneficiary an identity card (Employee ID Card) the beneficiary will produce this card at the time of admission /procedure /consultation for the purpose of identification.

3) Suryansh Hospital will provide cashless facility to the beneficiary up to the amount agreed upon.

5) KASHI INSTITUTE OF TECHNOLOGY will not interfere in the treatment and medical care provided to its beneficiary by Suryansh Hospital.

6) Suryansh Hospital will not disclose any information about beneficiary or KASHI INSTITUTE OF TECHNOLOGY business activities and will not share such information with outsiders or other agencies involved in similar business.

7) This agreement shall come into force with effect from 01st April, 2022 and will remain in force until terminated by the either party by giving to other party not less than 3 months notices in the Writing. In the event of termination of agreement KASHI INSTITUTE OF TECHNOLOGY will be responsible for the payments of all bills prior to the date of termination.

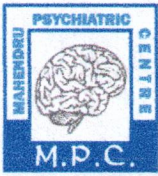
